

Personal Protective Equipment (PPE) and Financial Resources for Specialized Transportation Providers

According to results from the Missouri Specialized Transportation Provider Survey, 85% of responding agencies have an ongoing need for PPE, 74% of agencies have an ongoing need for cleaning supplies, and 63% of agencies are either concerned or unsure about their future ability to deliver transportation services due to impacts related to the COVID-19 pandemic.

To help respond to these critical needs expressed by agencies and organizations in order to safeguard and protect the health and wellbeing of Missourians, the Missouri Transportation Task Force has compiled the following resource guide to assist Specialized Transportation Providers in meeting the needs identified by the survey.
